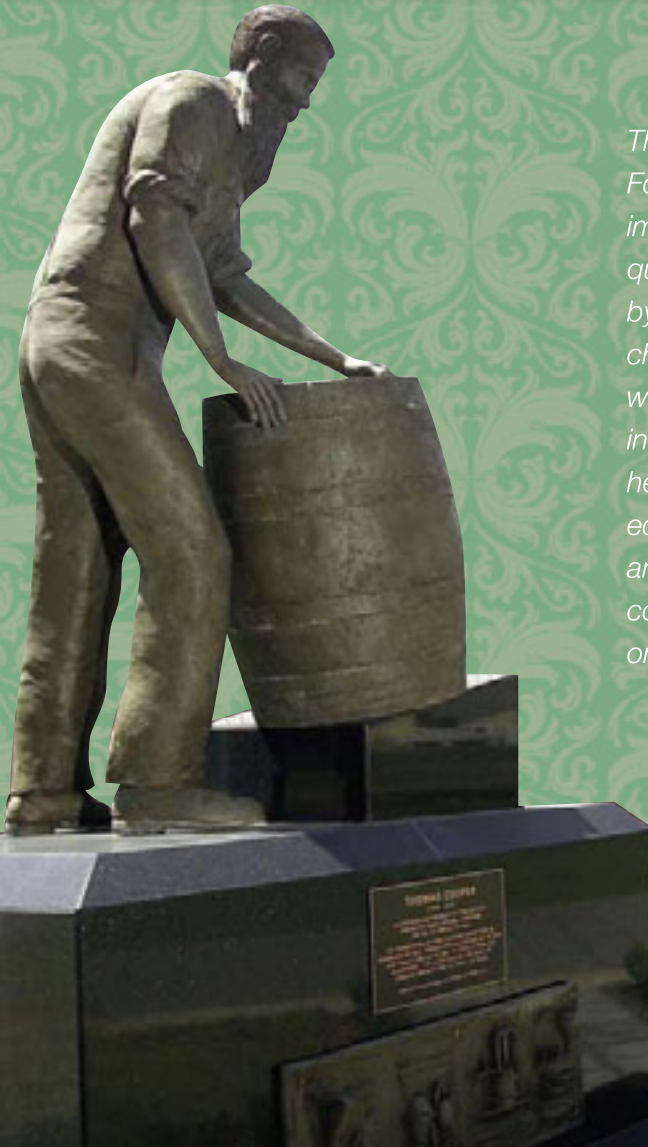

Annual Report Summary 2007 - 2008



The Coopers Brewery Foundation aims to improve and protect the quality of life of Australians, by providing support to charitable organisations with recognised strengths in medical research and health care, in youth education and aged care, and in fostering family and community support based on Christian values



This past year, being the second year since the Foundation's inception, has exceeded my expectations in many respects.

The Foundation doubled its distribution funds this year, providing funding of \$176,214 to 18 Australian charities. It is pleasing to see the diverse range of recipients, through many varied projects and programs, who have benefited from this funding. Programs supported have included First Aid training in regional and remote South Australian schools, funding camps for ability impaired adults and 'at risk' children, the provision of food for a homeless shelter over a 9 month period, and numerous medical research projects.

This funding increase was made possible by the Foundation achieving total revenue this year of \$246,407, tripling last year's income. Activities contributing to this increase included the Coopers Brewery tours, speaking engagements undertaken and a significant increase in contributions from shareholders, staff and suppliers.

I wish to reassure all supporters of the Foundation that 100% of their donations are being distributed to improve the lives of many disadvantaged or suffering Australians. All funds received are distributed directly to Australian charities, as all of the Foundation's expenses are covered by Coopers Brewery Limited.

My thanks go to all our supporters, with a special mention to Castlegate VGS Pty Ltd for their most generous donation of \$50,616.

The Foundation is a major commitment by Coopers Brewery to the health and welfare of Australians, and is an investment for the community which has long supported us. I am very proud of our achievement to date, and would like to thank my fellow Governors for their contribution and support over the past two years.

As we enter our third year, I trust that we, together with our supporters, can continue to effectively increase our activities for the benefit of those less fortunate.

A gentleman diagnosed with Mesothelioma was not expected to live very long and sought support from the Asbestos Diseases Society SA. Cooper provided him with comfort and company, and they became great and inseparable friends.

As the gentleman's illness progressed, he was forced to spend longer periods in hospital, and Cooper, although lonely, patiently waited for him at home and was cared for by a neighbour. As time passed, the heart-breaking decision was made to give Cooper away, just before the disease took his life. Thankfully, our friends at the Asbestos Diseases Society found Cooper a new companion with a lady, who was very lonely after losing her husband.

Beneficiaries

The Foundation distributed \$176,214 to 18 Australian charities during the past year, supporting the diverse range of worthy charity projects listed below:

Asbestos Diseases Society of SA Inc • \$5,000

To assist funding of a social worker to visit those suffering from chronic Mesothelioma and provide families with valuable support.

Camp Breakaway Inc • \$6,975

To enable four physically impaired adults to attend a purpose designed camp to develop confidence and experience new skills.

Central Coast Emergency Accommodation Services Ltd • \$10,000

To purchase food for the Donnison Street Free Homeless Restaurant, which provides 200 meals per day for homeless, financially disadvantaged and socially isolated people.

Cora Barclay Centre • \$5,000

To part fund the Adelaide visit of Canadian specialist Dr Perigoe, who provided training and mentoring to therapists working with hearing impaired newborn babies.

Cystic Fibrosis Victoria Inc • \$1,500

To cover costs for clients urgently requiring physiotherapy support, caused by the most common genetically inherited and life-shortening condition affecting young Australians today.

Edmund Rice Camps (SA) Inc • \$5,120

To fund a camp run predominantly by youth volunteers, assisting children from financially disadvantaged families.

Epilepsy Association of SA/NT • \$9,650

To produce an educational DVD 'What's Happening to Me?', assisting clients and their families when a family member is first diagnosed with Epilepsy.

Foodbank SA • \$500

To purchase the equivalent of \$5,000 worth of winter supplies for a South Australian outreach program.

Jumpstart Care Inc • \$6,919

To fund mentoring and support programs run entirely by volunteers for both young people and seniors in Port Pirie, South Australia.

Leukaemia Foundation of Qld • \$12,500

To part fund research into childhood leukaemia, the most common form of childhood cancer.

Mallee Family Care Inc • \$15,000

To fund the 'Chances for Children' program, which assists young rural people in obtaining tertiary education, where drought and distance barriers exist.

Minda Inc • \$9,900

To purchase a lifting chair for the senior citizens at the Pat Kaufmann Centre, optimising their comfort and minimising health risks to their carers.

Scouts Australia (SA Branch) • \$12,000

To fund a new junior adventure playground at Woodhouse Activity Centre in the Adelaide Hills, which will provide challenging and dynamic activities for many young people.

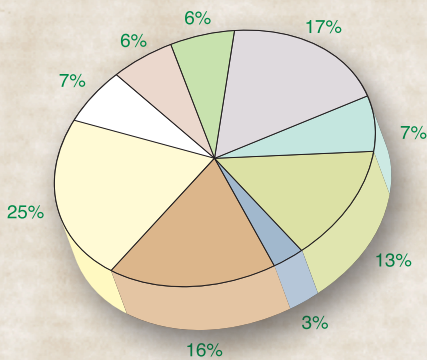
¹ These expenses represent bank fees, which were fully reimbursed by Coopers Brewery Limited and are included in the revenue from operating activities.

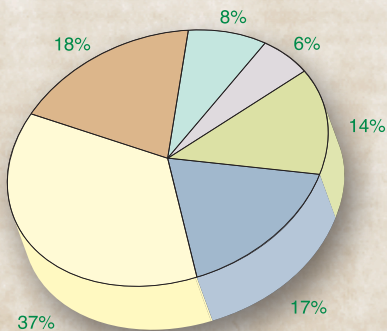
