CHAIR'S REPORT

2020-2021



It is with more confidence this year that I report the activities of the Coopers Brewery Foundation.

Following the initial profound effects of the COVID-19 pandemic on the Foundation last financial year, with the cessation of Brewery tour income and the cancellation of the annual Golf Day, the income rebounded, thanks largely to our generous donors.

With general donations totalling over \$354,000 for the year, the Foundation acknowledges all donors, including staff who gave more than \$62,000, and shareholders over \$90,000. Other donors contributed around \$200,000, including \$11,000 from Beerenberg, taking their total donations to \$109,000. Platinum donors Jo Cooper and Castlegate James were once again very generous.

The Foundation donated \$403,550 to 16 charities, including the three Sustainable Giving recipients; Christians Against Poverty, Australian Literacy & Numeracy Foundation and most recently Neuroblastoma Australia. Staff donations supported the United Way Imagination Library and the Leeuwin Ocean Adventure Foundation voyage.

This brings the total donated since inception to \$5,841,493, supporting 321 charitable projects.

The 12th Foundation Golf Day was held in May, to great success and over \$150,000 was raised for the Foundation's Sustainable Giving program.

Thirty-one corporate teams participated on the day and later enjoyed an auction dinner, hosted by cricket legend Wayne Phillips.

Recycling donations rebounded this year helped by the sales of scrap metal and although tours of the Brewery were still on hold, sales for future tours were equivalent to the previous year. Coopers Brewery online and museum shop merchandise sales continued, and 20% of the gross profit on staff sales were donated to the Foundation, again raising over \$6,000.

In a ground-breaking decision which will cement the future of the Foundation, the Board of Coopers Brewery Limited elected to donate \$4m to the Foundation's perpetual fund. A further commitment of annual giving to the fund of 1.5% of pre-tax profits was endorsed. It is the intention of the Coopers Board that this regular giving continues at these levels, pending liquidity requirements, until the Foundation reaches an investment level of \$20m, allowing for meaningful distributions to charities and longevity of the Foundation.

Thanks go to the Foundation Investment Committee and JB Were, which continued to administer and oversee the investments in a variety of Australian and international equities, together with cash holdings and the Aspire Social Impact bonds. Dividends and imputation credits from the fund totalled \$176,000, and total assets, including cash, amounted to more than \$10.5m.

I take this opportunity to thank Executive Officer Briony Neindorf, who has completed four years dedicated service in this role, giving of her time and energy to administer the Foundation, and wish her well in her next move within the Coopers organisation. I welcome Jasmin Barry-Keen as her successor and look forward to her input over the coming years.

On behalf of the Foundation Governors, I wish to thank Paul Cenko and his team at KPMG who have again donated their time auditing the Foundation accounts, and the team at On:Creative for producing the annual report, free of charge. Finally, I thank the Board of Governors for their time and expertise, and our Patrons Jo Cooper and Glenn Cooper, along with the Coopers Board of Directors for their ongoing support, ensuring the Foundation continues *brewing support for the community*.

SUSTAINABLE GIVING

THE FOUNDATION SUPPORTS SUSTAINABLE GIVING RECIPIENTS WITH \$150,000 IN FUNDING OVER A THREE-YEAR PERIOD.

Charities are selected on a rotating basis from the following sectors, identified in the Foundation's Mission Statement ; • Health, medical research and aged care
• Community support projects based on Christian values • Youth education

The inaugural beneficiary of the Sustainable Giving initiative, the Australian Dental Outreach Foundation, has now received the full \$150,000 and extend their gratitude for the support provided since 2017. They were able to provide dental care for aged-care residents to control and prevent pain, eating and communication difficulties, and social embarrassment associated with dental-related problems.

This year saw health, research and aged care supported again and was awarded to **Neuroblastoma Australia** for their research to progress to clinical trials. Neuroblastoma is an aggressive childhood cancer with survival rates of 50% and those who do survive often have long-term side effects from treatment. Around 60 children are diagnosed each year with Neuroblastoma and are, on average, just two years old. The Venetoclax project involves researching effective treatments, using approved drugs and testing various combinations.

Neuroblastoma joins 2019's beneficiary, the **Australian Literacy and Numeracy Foundation** (ALNF) and 2018's beneficiary, **Christians Against Poverty** (CAP), as the third current Sustainable Giving recipient.



Funding for **ALNF** has supported their Early Language & Literacy Central Goldfields Project, targeted at improving the literacy outcomes of children in one of the most socio-economically disadvantaged areas in Victoria. Challenges include health and developmental issues, intergenerational illiteracy, and economic disadvantage, which impact children's ability to learn and engage in education. The program provides families and community members with the skills required to improve children's long-term educational outcomes.

"Schools and Early Childhood services within this Shire have taken a community-wide response to the Early Years Language and Literacy program. This has increased the overall children's school readiness in regards to consistent teaching practices around literacy and oral language development compared to previous years where the strategies were not as prevalent from Kinder to Prep. I honestly believe that the ALNF program has been extremely beneficial and a catalyst for improving children's oral language and literacy skills in our Shire"

CAP has used their funds to help establish seven new debt centres in NSW. This financial assistance model connects church partnerships to personal and holistic debt help. Over the three years, this project aims to reduce the impacts of crippling debt for more than 500 individuals in seven communities, especially at a time when many families face financial uncertainty.

STAFF GIVING

COOPERS BREWERY EMPLOYEES HAVE CONTRIBUTED A TOTAL OF \$62,742 THIS YEAR.

The company's Guiding Principles of Passion, Respect, Responsibility, Consistency and Service resonate with the Coopers community and inspire an ethos of giving back to those in need. The Coopers Board and Governors of the Foundation are delighted that employees share their vision and these values, including philanthropy.

The following charities benefited from donations in the name of Coopers Brewery staff:

UNITED WAY SA \$27,500

United Way SA's **Imagination Library** is an early literacy program that provides monthly home delivered book packs to children 0-5 years old living in disadvantaged communities. Each child in the program receives the book pack, addressed specifically to them, with new, quality, age-appropriate books along with reading tips and guides for the parents to help engage their child with reading. The funding given will provide 230 children with a total of 2,760 book packs.

Evaluations of The Imagination Library program show that children and parents are engaging in more reading activities with daily reading increasing from 10% to 60%, and that time spent reading is more than doubling. United Way SA also run local literacy events and activities to encourage community engagement.

Some families have provided feedback about the program:

"I have had literacy problems all my life and these books you send for my daughter are helping me get better at reading and my confidence in reading is increasing when I read to her."

"Thanks so much. The books have been really good. Being addressed to her was special and she got really excited when they came and there was a new book to read. She can tell you what an author and illustrator do."

"Amazing how she has grown and is talking non-stop about her books. She tries to read on her own. I am very happy with her progress."

"It's been awesome, we have loved it. We now have a nice library collection. The book tips take the guesswork out of what to focus on."

"Thank you it's wonderful. He has autism and loves getting them in the mail. It's great he wants to read and will repeat the stories."



LEEWIN OCEAN ADVENTURE FOUNDATION \$18,150

Leeuwin Ocean Adventure aims to enrich the lives of young people through adventure, participation and challenge. **The Ultimate Challenge Voyage** has offered young people with an intellectual, physical or sensory challenge a life-building adventure which is a powerful source of cognitive and emotional stimulation and accomplishment. The Leeuwin Ocean Adventure Foundation is the only sail training organisation in Australasia to offer young people with disability the opportunity to join a 5-day sail training, tall ship voyage in a unique, challenging and fully supported environment.

All participants work as a team within their watch, and experienced crew and volunteers collaborate with them to be independent and involved as trainee crew members.

"The funding will allow access to this unique and extraordinary voyage program for people with disability – people who could otherwise only dream of five days at sea on Australia's largest sail training tall ship, making new friends, facing new challenges and experiences, learning new skills and achieving more than they thought was ever possible."





GOLF DAY

THE 12TH COOPERS BREWERY FOUNDATION GOLF DAY WAS HELD ON FRIDAY 1ST MAY, FOLLOWING THE CANCELLATION OF THE EVENT IN 2020 DUE TO COVID-19.

Fortunately, restrictions were lifted between the states and several teams from Victoria and NSW attended. With 31 teams, including 12 sponsor teams, 124 players and supporters, the event **raised over \$150,000 for the Foundation’s Sustainable Giving Program.**

The program will aid a charitable organisation in the area of family and community support based on Christian values. The successful candidate, Prison Fellowship Australia, announced in September 2021, will receive \$150,000 paid in three annual instalments of \$50,000.

There were a variety of activities held on several holes together with a Coopers Aussie IPA hole, a Sapporo hole, a whisky tasting and burger van. Several of the sponsors held activities which raised over \$5,000 on the day.

Following the day of golf was an evening of entertainment with former Australian cricketer Wayne Philips as host and a successful auction held by Nathan Casserly of Ouwens Casserly, raising more than \$32,000.

Thanks go to the many individuals involved together with the players, sponsors, teams and companies giving their time and generosity to make the event a success.

**4 AUSSIE HEROES FOUNDATION
'TRIUMPH OVER TRAUMA'
\$25,900**

The **Triumph over Trauma** program is an 11-day live-in rehabilitation course for military and first responder personnel, past and present, who are suffering and struggling with PTSD and mental health issues. This program includes approximately 100 sessions which represent a combination of education and activity-based therapy with participants requiring medical clearance from their GP or mental health specialist to meet intake assessment criteria.

A maximum of 10 participants take part in each of these programs and their partner/support person attends part of the program which involves sessions of empathy, understanding and relationships.

A three-day "Refresh" program is conducted three months after the main program for the same participants whose improvement in their quality of life, benefits not only them, but that of their families.



**DISMANTLE
\$15,000**

Dismantle delivers dynamic outreach programs that empower at-risk disadvantaged young people, helping them rediscover and achieve their ambitions. The **BikeRescue Project** is a youth development program that uses hands-on skill-building to engage and mentor young people in need of support. During BikeRescue, participants fully strip and rebuild two bikes each, the first is donated to charity and the second one they can customise and keep for themselves. Mentors work alongside the participants, exploring their mental health, hobbies, passions and vocational aspirations, while helping them identify their barriers and how to tackle their challenges. Dismantle provides ongoing training, equipment, guidance and support to ensure sustainability and impact for young people and their communities.

Funding will help to deliver the BikeRescue Program to five groups of 10 at-risk young people within the Perth metropolitan area.



**GIANT STEPS AUSTRALIA
\$15,000**

Giant Steps Australia is a training hub for children and young adults with autism, designed to provide each student with the opportunity to reach their full potential, while giving families support and guidance. They also strive to improve the wider community's understanding of autism and its complex nature, and to research and develop world's best practice among carers and professionals. Giant Steps teachers, therapists and educators work intensively on the student's individual goals and curriculum outcomes within a caring and supportive environment, taking a 'best fit approach' to place students in the most appropriate program to best meet their needs.

The aim of this project is to equip four new classrooms and a dedicated training space as well as provide an online training platform to deal with COVID-19 restrictions.





HOPE CITY MISSION 'STAIRWAY TO HOPE'

\$15,000

Stairway to Hope has the mandate to build healthy and strong communities by providing a safe place for people in financial hardship to receive support, education, and hope for their current situation. Due to COVID-19, in-person workshops have ceased and were replaced with an online program. The project will empower 70 families experiencing financial hardship to become financially secure, in housing, and with life-skills, by providing solutions to homelessness, family violence and financial literacy. The client is tracked over a 16-week cycle and then monitored until they are stable and secure.



KEVIN HEINZE GARDEN CENTRE 'GROW'

\$20,000

The Peppertree Place Café at Kevin Heinze Garden Centre is a sustainable café, community meeting place, and vocational training program for young people with a disability. The Grow program aims to help participants build resilience, self-esteem, develop and improve life skills and gain confidence in a workplace setting before exiting the program into mainstream employment.

The project will focus on providing hospitality skills covering customer service, barista training and food preparation. Funding will target 20 participants, with the expectation that at least five of them will go on to regular employment.



KINGSWAY COMMUNITY CARE

\$12,000

Kingsway's Community Care is a Christian organisation providing emergency and crisis accommodation for people experiencing homelessness and/or domestic and family violence. In their four years of operation, the Platform Nine project has supported over 600 people in the SE Sydney region. However, in the last 12 months there has been a 300% increase in demand for services at their new site, supporting 197 women, 136 children and 43 males in that time. Transporting clients to and from necessary appointments such as legal, psychological, medical and housing appointments takes the strain off clients and reduces the amount of time taken when reliant on public transport.



REFUGEE ADVICE & CASEWORK SERVICE

\$30,000

The Refugee Advice & Casework Service is a strong, independent public voice for the rights of refugees and people seeking asylum. To qualify for asylum in Australia, they must provide a detailed account of why they fled their home country, including intricate and personal facts of abuse. However, as they are largely illiterate in their own language as well as having very limited English, without assistance from interpreters they risk providing the wrong information, misinterpreting vital questions or being misunderstood. As such, they risk being unsuccessful with their asylum seeker claim and being sent back to life-threatening situations in the country from which they fled.

This project will provide crucial language interpreting support to 500 Rohingya people/families, to assist them through the complex English-only forms and process of applying for asylum in Australia.





SECOND CHANCES

\$6,000

Second Chances Family Care workers give emotional and spiritual support to families who have a parent in prison. They also identify the practical needs to help the children feel normal, which greatly reduces any resultant stigma they may feel. These needs include school uniforms and shoes, clothes, medical and dental appointments, and school excursions. This program will help with regular attendance at school, reduction in anti-social behaviour and improvement in family functioning.



SPORTS CHAPLAINCY AUSTRALIA

\$30,000

Life Saving Chaplaincy Australia is a dedicated volunteer network of Chaplains serving local life saving communities throughout Australia.

The aim is to increase the number of volunteer Chaplains who offer pastoral care, social and emotional comfort to the 100,000 volunteer lifesavers performing 10,000 rescues on our beaches each season. Whilst there are support processes to help members traumatised by critical incident involvement, many will not access the support they need because of denial, or the stigma attached in needing mental and emotional healing.

The trained Chaplains play a vital part for affected members by getting alongside them as a friend, monitoring their emotional and mental wellbeing, and encouraging them towards any professional help they may need.



AUSTRALIAN SPORTS FOUNDATION

\$9,000

Backed by the Australian Sports Foundation, **The One & All Challenge** aims to support the continued activities of South Australia's tall ship 'The One & All' and maximise the benefits the ship brings to the people of South Australia and the wider community, including Youth Development Voyages. This program provides the framework for personal development through participant interaction with the sailing environment. Participants are responsible not only for themselves, but for the care and safety of others, thus the intensity of the interdependent community that leads to a strong social experience.

The project involves taking eighteen 15-18 year olds for five-day development voyages, with up to five participants coming from disadvantaged areas. The young people, cut off from all outside communications, learn how to sail the ship themselves, with all operations carried out manually. This provides a series of unique challenges many of which can only be accomplished with precise teamwork. They must set sails, climb the rigging, learn navigation and helmsmanship and many other tasks necessary to operate a large sailing vessel – all while standing four-hour watches 24-hours a day.



WAVES OF KINDNESS

\$30,000

Waves of Kindness supports financially disadvantaged people in the Noosa Shire and those at risk of homelessness, chronic illnesses and the unemployed. The organisation runs a breakfast program with nine local primary schools, feeding over 500 school children 1,075 meals a week. The aim is to reduce the number of children who go hungry, as current data suggests each week 18% of children attend school without breakfast and go to bed without dinner. Replacing their old delivery van will help provide meals to an additional two schools and feed 200 more children, as well as reduce repair costs and time off the road.

PHILANTHROPY UPDATE

LAST YEAR'S ANNUAL REPORT SUMMARISED JB WERE'S 'OUTLOOK FOR PHILANTHROPY DURING COVID-19'. THIS REPORT HIGHLIGHTS THE JB WERE NAB CHARITABLE GIVING INDEX OF JULY 2021.

This study on the examination of giving in Australia points to early signs of recovery following the biggest fall in giving in the country's history.

- Giving peaked in February 2020 with bushfire support and before COVID-19 prevented many fundraising activities.
- There was a fall of 4% in giving to December 2020 when compared to the previous calendar year, and 16% when compared with the previous financial year's first six months.
- There is evidence suggesting late 2020 may have been the turning point for a recovery in giving (e.g., Good Friday Appeal in Victoria raised more than \$17 million).
- Normally, recovery from philanthropic downturns is swift.
- The largest falls were in arts, education, social services, development and housing, with smaller falls in environment, animals, and religion. The causes which performed well during the overall decline were health and international aid.
- JB Were analysis showed that high net worth giving and corporate community investment both grew strongly in 2020. They conclude that this reflects the differing economic outcomes across the economy and long-term trends of widening income and wealth inequalities in Australian society.
